It's a message soon to become clear across parts of Austin, thanks to a grant provided by Williamson County Sheriff, **Mike Gleason**.

Gleason's grant enabled **Stefanie Turner**, the founder of Texas Against Fentanyl and a full-time working mother, and friends to create a first wave of needed resources.

Turner formed the nonprofit organization after losing her 19-year-old son Tucker to fentanyl poisoning in September 2021.

Turner and TXAF volunteers haven't waited for the grant, but resource constraints—some of which still exist—prevented them from action sufficient enough to meet the need.

To date, Texas Against Fentanyl has spoken to students in numerous schools, set up awareness booths at local venues, and formed a group for, tragically, a growing number of grieving parents: **AngelMoms**, orchestrated by **Carilu Bell**, who lost her own son, Casey Dean Copeland to fentanyl in August of 2021.

Austin-based website development company, **Studio 3 Marketing**, also provided resources and talent to launch the organization's website.

It's an acceptable starting point to tackling a pressing problem.

Lovingly dubbed 'The Tucker Project' by the publisher, the curriculum will:

• Educate students and communities about the dangers of fentanyl.

- Help participants identify the risks and harms associated with fentanyl use
- Point out signs of fentanyl use
- Instruct how to respond in the event of an overdose

Included in the curriculum design will be:

- Classroom discussions and case studies
- Guest speakers from healthcare and law enforcement professionals
- Assessments of knowledge and skills
- An emphasis on safety and responsibility.

What You Need to Know:

Fake Pills & Fentanyl


- Fake pills laced with fentanyl may look actual medication.
 - "Fake pills are made to look like OxyContin", Xanax", Adderall", and other pharmaceuticals. These fake pills contain no legitimate medicine. Fentanyl is also made in a rainbow of colors so it looks like candy." U.S. DEA
- Six out of every 10 of these pills could cause death. "DEA lab testing reveals that six out of every ten fake pills with fentanyl contain a potentially lethal dose." U.S. DEA
- Drugs are different now than when you were young. "The drug landscape is dramatically different from when you grew up, or even from just a few years ago. All parents and caregivers need to be educated on current drug threats...." U.S. DEA
- Pills received from anywhere but a legitimate pharmacy could cause death due to fentanyl. "...pills purchased outside of a licensed pharmacy are illegal, dangerous, and potentially lethal."

- Dealers target young people through social media. "Drug traffickers advertise on social media platforms like Facebook, Instagram, Snapchat, TikTok, Twitter and YouTube." U.S. DEA
- You would not be able to see, smell, taste, or test for deadly levels of fentanyl in a fake prescription pill. "Drugs may contain deadly levels of fentanyl, and you wouldn't be able to see it, taste it, or smell it." U.S. CDC

She did not want to die, she had so much to live for."




